STATUS UPDATE AND REQUEST FOR DEADLINE EXTENSION
LOS ANGELES COUNTY SHERIFF'S DEPARTMENT
LOMITA SHERIFF'S STATION

The Los Angeles County Sheriff's Department (Department) received a Directive to Take Corrective Action in Response to Unauthorized Storage Tank Release (Directive), dated June 6, 2019, from the California Regional Water Quality Control Board, Los Angeles Region (Regional Board).

According to the Directive, the Regional Board has initiated an investigation to identify the possible source(s) of pollutants impacting the City of Lomita's Well No. 5 (Lomita Well No. 5). Since the Station utilizes an underground storage tank for gasoline and diesel fuel (UST), and the Station's UST may be hydrologically upgradient from Lomita Well No. 5, the Regional Board has identified the Station's UST as a potential source of the pollutants.

The Directive requires the Department to submit a work plan proposing the advancement of soil borings into groundwater, and the collection of soil and groundwater samples, to determine if pollutants are present at the Station's UST. The Directive also requires the Department to provide fee title holder information for the Station. The deadline to submit the work plan and fee title holder information to the Regional Board is July 15, 2019.

A Tradition of Service — Since 1850 — Fee title information for the Station is attached hereto (see Attachment A). The Department, however, is dependent on others to prepare the work plan, and is bound by County policies to finance necessary services. The Department requested the Los Angeles County Department of Public Works/Geotechnical and Materials Engineering Division (DPW/GMED) review the Directive and develop a cost estimate to prepare the work plan. The Department then established the necessary funding mechanism to allow DPW/GMED to initiate the work in accordance with the Directive.

DPW/GMED anticipates completion of the work plan by August 30, 2019. Accordingly, the Department requests the compliance deadline be extended to this date. The Department and DPW/GMED are exploring all options available to expedite this work, and will advise the Regional Board if the requirements of the Directive can be completed prior to the requested extended deadline.
